The following is a list of agencies with direct or peripheral supervision into various operations of assisted living and housing with services establishments. The list also includes boards for different staffing cohorts as well as other constitutional offices with oversight or control over various parts of our business.

CABINET LEVEL DEPARTMENTS

Bureau of Mediation Services

This cabinet level department assists parties in resolving labor disputes; collective bargaining, representation, and trains worksite labor-management committees.

Department of Commerce

This department monitors insurance companies, some of which offer and provide long-term care insurance policies. These policies pay for certain long-term care services.

This department is responsible for economic development through direct funding and grants. Promotes business expansion and employee retention programs; provides oversight of grantees and other business operations.

This department ensures compliance with the Minnesota Human Rights Act and is charged with preventing discrimination within the state.

This department administers the Medical Assistance (Medicaid) payment program which in many cases is a majority of funding to providers. With these payments come multiple areas of oversight.

Office of Ombudsman for Long-Term Care—helps mediate disputes between consumers and providers of long-term care services including service terminations, rights violations, discharge and evictions, and assistance with public programs.

Office of Ombudsman for State Managed Health Care Programs—helps people in Minnesota's Health Care Programs (MHCP) who are required to be enrolled in a health plan. This includes people covered by Medical Assistance (MA), General Assistance Medical Care (GAMC) and MinnesotaCare.

DHS Background Study – required for individuals who provide direct contact services.

Department of Labor and Industry (DOLI)

This department regulates building codes, workers compensation, wages and general labor standards.

The Board licenses the administrators of nursing homes in the state. They also set the qualifications required for licensure, review, and act on complaints against licensed administrators, and refer consumers needing help to other state and private agencies.

CABINET LEVEL DEPARTMENTS

Department of Health and Human Services (HHS)

The Department is charged with the goal of protecting the health of all Americans and providing essential human services.

Administration on Aging

The AOA awards annual grants (computed by formulas) to State government agencies on aging and Native American tribal organizations to support programs mandated by the Congress in the Older Americans Act. The administration also awards discretionary grants to research organizations working on projects within the broad outlines of the Act. It conducts statistical activities in support of the research, analysis, and evaluation of programs to meet the needs of an aging population.

Administration on Developmental Disabilities

The Administration on Developmental Disabilities (ADD) is the U.S. Government organization responsible for implementation of the Developmental Disabilities Assistance and Bill of Rights Act of 2000, known as the DD Act. ADD, its staff and programs, are part of the Administration for Children and Families, of the U.S. Department of Health and Human Services.

Centers for Disease Control (CDC)

The Center works to protect public health and safety by providing information to enhance health decisions, and it promotes health through partnerships with state health departments and other organizations.

Food and Drug Administration (FDA)

This division of HHS is responsible for regulating and supervising the safety of foods, dietary supplements, drugs, vaccines, and biological medical products.

Centers for Medicare and Medicaid Services (CMS)

This division administers the Medicare program and works in partnership with state governments to administer Medicaid, the State Children's Health Insurance Program (SCHIP), and health insurance portability standards. In addition to these programs, CMS has other responsibilities including monitoring quality standards in long-term care facilities through its survey and certification process.
